EBN Email XML Enhancement

The US Bankruptcy Courts have enhanced their Electronic Bankruptcy Noticing (EBN) Email service to embed the variable data elements from a notice within a PDF file. EBN Email recipients are now able to access and process the case data elements from a PDF file. Using the eXtensible Metadata Platform (XMP) and XML standards-based extensible metadata, text data elements from the notice are now attached to the PDF document catalog as XML data. EBN Email users can now read a PDF file and extract case data presented in text format for viewing and/or processing.

Key Benefits of EBN Email XML Enhancement

- Enables flexible text search and retrieval of the variable data elements in a PDF notice – e.g.,
 - Court district name
 - Court district address
 - Court district code
 - Court district office code
 - Case number
 - Chapter
 - Debtor name
 - Debtor address
 - Joint debtor name
 - Joint debtor address
 - Debtor attorney name
 - Debtor attorney address
 - Judge initials
 - Title of notice
- Enables notice data element capture to facilitate business process automation, improve workflow and increase production efficiency
- Based on open standards and implemented as a common metadata interchange platform
- PDF image can be archived for record retention (regulated industries), fraud prevention, and audit trails

Technical Standards

This document is provided to assist you in preparing your system to receive and process Bankruptcy Notices sent as XMP data embedded in a PDF file. XMP is the standard by which XML data is placed in a PDF file. The XML data provided are the data elements for the bankruptcy case and does not contain the text of the notice.

The XML standard is based upon the Legal XML standard maintained by OASIS at: <http://www.legalxml.org/>. The Legal XML Electronic Court filing (ECF) 4.0 standard is used. ECF 4.0 is based on the National Information Exchange Model (NIEM). NIEM is sponsored by a partnership between the Department of Justice and the Department of Homeland Security. More information is available at <http://niem.gov>. Extensions to the Legal XML ECF standard have been included to meet the additional needs of bankruptcy noticing.

This guide is intended to provide software developers the information needed to extract the data from the PDF file and to parse the information for use in a recipient's account management system.

How to Use This Guide

This guide will provide:

- an overview of the XML structure,
- the code list for specific elements,
- example documents

XML Overview

The structure of the XML is largely based upon NIEM constructs. The property elements for identifying people, addresses and dates are good examples of this. One example is to identify the list of roles in a notice event separately from the contact information for each of the persons in the role. This design is for when one person fills multiple roles, but this is not typically done for bankruptcy cases. NIEM compliance is also why dates have a property defined, and then a Date or date/time tag inside them to specify the format of the element.

The information exchange protocol description (IEPD) is called a “CoreFilingMessage”. It should be noted that although the message id implies the use in filing, the implementation here is for a notice document between the Bankruptcy Noticing Center and any recipient in a bankruptcy case. In addition to the bankruptcy data, data about the bankruptcy notice is also contained in the XML.

The bankruptcy notice PDF document contains the XML embedded in the catalog. It is invisible to the appearance of the PDF document. The XML is an ASCII text element located between the opening and closing elements identified as:

Special Considerations

In a limited number of circumstances, non-conforming input data will generate an error. In these circumstances, instead of XML for a notice, the following XML will be generating indicating the input error:

Validation

The XML provided can be validated using commercial XML validation software and the schemas provided at <http://bankruptcynotices.uscourts.gov/EBN-BankruptcyCase.xsd>.

If you receive PDF files with multiple notices in each file, the XML must be split at the CoreFilingMessage tag into individual notices prior to running a validation.

May 2021 Update

Updated the XML Sample to reflect XSD version 1.2 and provided a newer example.

May 2016 Update

The May 2016 update improves the validation of the XML with respect to the designated XSD files. This section describes the changes made to the XML. The changes are primarily positional in nature and do not reflect the need for new tags, but the placement of the data within the XML is impacted.

The changes are:

1. The pointers to the XSD files are now directed at bankruptcynotices.uscourts.gov rather than either NIEM or OASIS. Accordingly, the XSD from those sites have been copied to bankruptcynotices.uscourts.gov. See the example at the end of this document for specific locations.
2. The opening tag documentation of `ebn:Batch` was incorrect. It is `ebn:EBNBatch`.
3. The `<nc:caseTitleText>` tag now contains joint debtor as well as debtor information if a joint case.
4. The `j:CourtEventSchedule` now contains a sub tag for `nc:ScheduleDate` and the `nc:DateTime` tag is within the `nc:ScheduleDate` tag. This is primarily applies to First Meeting notices.
5. The court address information for a section 341 meeting (aka First Meeting notice) has been changed from individual data elements to a block of address information within a `<ecf:CourtEventLocationText>` tag. In addition, this section is wrapped in an `<ecf:ChildDocketReference>` tag.
6. The `<ebn:CourtEventLocationText>` (note `ebn` vs `ecf`) description has been removed since it is not shown on the PDF file and contains no further details for the meeting location.
7. Date events that do not have a time normally associated with them had 00:00:00 added. The following fields have been changed from a date/time with 00:00:00 as a time to just a date field:
 - a. `ebn:BankruptcyFilingDate` – also moved from the `<ebn:BankruptcyCase>` tag to standalone

8. If a debtor or joint debtor contained a business tax ID, the tax ID has been moved from the <ecf:CaseParticipant> tag to the <ebn:BankruptcyDebtorInfo> <ebn:BusinessTaxIdentification> <nc:IdentificationID> tag set.
9. The case participant data for the Trustee was prematurely closed by a <ecf:/CaseParticipant> tag. The trustee data is now included prior to this closing tag.
10. Attorney address data is split into multiple <StreetFullText> tags, one for each line instead of all the lines in one tag.
11. Dismissal forms no longer have the ebn:CaseCourtEvent tag. The Dismissal date is now in the ebn:BankruptcyDebtorInfo tag.
